  - Badge printer is repaired and plastic badges are being produced moving forward; those that received a laminated badge can continue to use it but if damaged or does not hold up, email ccrecvolunteer@carrollcountymd.gov to request a plastic badge.
  - Volunteer list update was posted on 4/10; waiver column is on the listing and we will be updating Waivers received as we access the email system that was temporarily down for the past month.

- Team rosters are still being collected for possible Health Dept. contact tracing until further notice. Provide rosters to me by team and be sure the coach name and contact info is included. Providing team name or age level is helpful.
- Questions posed in reference to paid vs. non-paid volunteer: volunteers receive no payment or stipend as they are volunteering their time so there is no such thing as a "paid volunteer". They go through the NCSI background check annually and receive a "volunteer badge." Paid coaches/instructors who work with youth in any capacity must be fingerprinted at their own expense (must use our forms so that we receive their report when completed, see Maria for forms and more info about where to get fingerprinted) and they do not receive a Volunteer badge, they operate under a specific contract date or dates. If a badge is needed during instruction, please contact Becky and the department can provide one.

- Please share the following permit conditions:
  - Permit Conditions
    - Athletic field permit holders shall not apply fertilizers, additives for weed control
      or any other chemicals to grass fields without written approval from the County.
       All efforts must be in accordance with Maryland's Lawn Fertilizer Law.
    - Permit holders will supply a mowing schedule by volunteers, to include areas being mowed and level the grass will be mowed, to the Department of Recreation and Parks. Carroll County's mowing schedule, weather permitting, is every 7 to 10 days.
    - This permit is for use of field space only (unless otherwise noted). Limited bathrooms/port-a-pots may be onsite; supplemental mowing and additional portapots (location must be approved by County) are the responsibility of the permit holder.
